BACKGROUND: Failure to communicate effectively has been identified as a contributing factor to medical errors. The purpose of Patch Review (Online Medical Consultations) is to improve the communication between base hospital physicians and paramedics through a formalized feedback mechanism.

POLICY: The RPPEO has a Patch Review process which provides feedback to Paramedics and Base Hospital Physicians involved in Online Medical Consultations.

PROCEDURE:

1. All Online Medical Consultation forms (Patch Forms) will be documented electronically and available to be linked to the corresponding Ambulance Call Reports (ACRs), on an internal platform.
2. Applicable data elements are captured from the Patch form and entered into electronic system.

3. ACRs will be reviewed for completeness, appropriateness and accuracy of patch information.
4. Base Hospital Physician Patch forms will be reviewed for completeness, appropriateness and accuracy of patch information.
5. Patch audio will be assessed for completeness appropriateness, and accuracy associated with the standard of care and Medication and Procedure standards.
6. Feedback will be provided to the paramedic and BHP via email by forwarding the audit findings, electronic patch form, audio file and de-identified ACR where appropriate.
7. Any review findings will follow the standard call review policy QPS 120 – Quality-of-Care Review.
